Grant winners will be announced at the CANNT Annual General Meeting. Funds must be used in accordance with specifically outlined grant timelines.

### **Applicant Eligibility Criteria**

One applicant will be selected from the applications submitted for each of the grants. The successful applicant will be selected based on the merit of their submission regardless of their country of origin.

In the event that one of the grant areas has no applications in a given year, consideration will be given to provide funding to more than one applicant in another category. Amgen and/or the CANNT executive will reserve the right to withhold any grant on the basis of lack of suitable applicants.

CANNT BOD members, during their tenure on the board with the exception of the Journal Editor, are not eligible to apply for a grant.

Applicants must meet the specific requirements for each individual grant and satisfy the following criteria:

- 1 The applicant must be a registered member of CANNT at the time of application.
- 2 The applicants' major area of work must involve nephrology health care.
- 3 Successful applicants are not eligible to apply for an additional grant the granting year following their award.
- 4 The applicant must submit a brief resume with his/her application form demonstrating evidence of continued commitment to nephrology healthcare including CANNT activities

(e.g. attendance at CANNT Symposia, oral or poster presentations.)

- 1 The applicant must be willing to submit an abstract for presentation at the Annual CANNT Symposium the year following receipt of an Amgen grant. It is understood that conference registration, return airfare and accommodation will be sponsored by Amgen Canada should the abstract be accepted.
- 2 The applicant (if applicable, i.e. Junior/Senior Researcher) will be required to submit a minimum 250 word report (i.e. New educational material) to CANNT and Amgen Canada within one month of completion of the Grant or Preceptorship/Mentorship with a view to publish in the CANNT Journal.
- 3 Entries must be submitted on the official application form.

## International Nursing Nephrology Travel Grant

Amgen Canada, in partnership with CANNT, is pleased to support the nephrology nursing community with grants to facilitate attendance at select symposia as follows:

**One grant of \$3,000 will be awarded to the successful applicant to attend a major international nephrology conference as follows:**

- Kidney Foundation of Canada Annual Leadership Conference
- European Dialysis and Transplant Nurses Association (EDTNA) Annual Symposium
- American Nephrology Nurses Association (ANNA) Annual Symposium
- Annual Dialysis Conference

### Objectives

- To provide support for the ongoing education of current nephrology staff via attendance at international meetings in the area of nephrology patient management or research
- N.B. An international conference held in Canada would qualify for this grant.
- • To facilitate nephrology nursing education and knowledge transfer The \$3,000 will contribute to the following:
  - Travel costs
  - Accommodation
  - Registration
  - Meal allowance per diem

Applicant requirements must be completed as outlined in the Program Charter

- 1 The applicant should have supportive documentation from his/her direct manager and/or Director (where appropriate). Supportive documentation includes signature on the application form and a letter of reference.
- 2 Written application for the Amgen Canada International Conference Travel Grant for nephrology nurses (500 words maximum) outlining the expected objectives / benefits for the applicant's professional development, also including anticipated expenditure as well as proposed benefits to the applicant's institution. The application is to be typed and posted with the application form.
- 3 Amgen Canada International Nephrology Conference Travel Grant for nephrology nurses must take place before end **June 1 of the granting year.**
- 4 The successful applicant must be willing to present his/her Amgen Canada International Nephrology Conference Travel Grant report through an educational program at his/her institution as negotiated with his/her manager.
- 5 The successful applicant must be willing to present his/her Amgen Canada International Nephrology Conference Travel Grant report at an Amgen organized educational meeting or submit an abstract to the next CANNT National Conference.

## **Objectives**

- To promote the value of nursing research and promote future participation and interest from colleagues in nephrology research.
- To facilitate education and knowledge transfer in the specialty of nephrology nursing.
- To facilitate and promote evidence-based nephrology nursing practice

**Amgen Canada Research Project Grant – Novice Researcher, to the value of \$2,000 A nurse with 2 years or less nephrology experience (minor project)**

**Amgen Canada Research Grant – Experienced nurse, to the value of \$4,000 More than 5 years nephrology experience (major project)**

A member of the CANNT executive will act as a mentor & assist as required.

## **Applicant Requirements**

1 The applicant should have agreement from his/her direct manager and/or Director (where appropriate). Supportive documentation includes an authority signature on the application form and a letter of reference from the direct manager.

2 A written application, no greater than 1,000 words, must be submitted for the Amgen Canada Research Project Grant. The application is to be typed and posted with the application form.

The proposal should include:

- Clear hypothesis
- Clear objectives and aims
- Relevance to current nephrology nursing practice
- Clear methodology
- Expected outcomes
- An itemized budget outlining anticipated expenditure and any institutional in-kind support.

1 The Amgen Canada Nephrology Research Project Grant project must be completed within 24 months of announcing the successful applicant. A report of approximately 5,000 words must be submitted to Amgen and the CANNT executive within three months of completing the project. The successful applicant will be strongly encouraged to submit research results/findings for publication shortly thereafter.

2 The successful applicant should be willing to present his/her Amgen Canada Nephrology Research Grant report through an educational program at his/her institution as negotiated with his/her manager.

3 The successful applicant must be willing to either present his/her Amgen Canada Nephrology Research Grant Project and results at an Amgen organized educational meeting or submit an abstract to the next CANNT National Conference.

## Objective

- To provide opportunity for nephrology nurses in specialty roles to gain knowledge through preceptorship/mentorship opportunities within an area of practice that will complement their existing roles in nephrology nursing.

### **Amgen Canada Nephrology Nurses Preceptorship/Mentorship Grant – Nurse Practitioner, to the value of \$3,000**

Mentorship in an environment chosen to build on current NP practice and knowledge base (i.e. in Canada, fully established centre of excellence; out of country approved centre would be considered via application process.)

### **Amgen Canada Nephrology Nurses Preceptorship/Mentorship Grant – Vascular Access, to the value of \$3,000**

Mentorship in an environment chosen to build on current Vascular Access practice and knowledge base (i.e. in Canada, fully established centre of excellence; out of country approved centre would be considered via application process.)

### **Amgen Canada Preceptorship/Mentorship Grant – Outreach Experience, to the value of \$2,000**

Mentorship in an environment that allows for the applicant to reach out to special populations in order to implement a change strategy; i.e. aboriginal populations and CKD prevention programs.

- 1 The applicant should have agreement from his/her direct manager and Director of Nursing or Nurse Unit Manager (where appropriate). This requires an authority signature on the application form and a letter of reference from the direct manager.
- 2 Written application for the Amgen Canada Nephrology Healthcare Professional Preceptorship/Mentorship Grant (500 words maximum) stating the expected benefits and proposed implementation of these benefits for the applicant's institution. The applicant should be currently employed in a nephrology clinical environment, which should be clearly demonstrated in a submitted resumé.

- A preceptorship/mentorship in an environment chosen to build on current technological practice and knowledge (i.e. in Canada, fully established centre of excellence; out of country approved centre would be considered via application process)
- A small research project

**Applicant requirements include:**
